ACCOMODATIONS

I recognize this dog will be maintained in an approximately 8' x 20' outdoor kennel run with a plastic dog house for shelter. I further recognize that during the cold and damp months, this dog may be brought inside at night to sleep in an airline crate, but that during the summer months and during periods of good weather, my dog will sleep outside in his/her kennel run. **Initial: _____**

HOURS OF KENNEL OPERATION

Hastings Island Hunting Preserve ("HIHP") hours are from 7:00 AM to 4:30 PM. HIHP is closed the entire month of June and on all Tuesdays and recognized Holidays. During our off season (mid-March to mid-September HIHP is also closed on Mondays. **Initial: _____**

OWNERSHIP

I, the undersigned, represent that I am the legal owner, and/or lawful agent of the legal owner of the dog, described herein; and make this application and agreement with the legal owner's knowledge and authorization. I guarantee that this dog is in good health and is not known to have been exposed to any contagious diseases within the past thirty (30) days. I agree to provide HIHP with proof of dog's Rabies and DHLPP vaccinations within the past three years, and proof of a bordatella vaccination within the past six (6) months. **Initial: _____**

ILLNESS OR INJURY

If the aforementioned dog becomes ill or injured, HIHP shall attempt to notify me, or if I cannot be contacted, they shall attempt to contact the designated emergency contact I have provided. If I cannot be contacted, HIHP and its agents are authorized to have this dog treated by a veterinarian of their choice. I hereby authorize the veterinarian or a Veterinarian Emergency Hospital to perform treatments, administer medicine, or provide other attention which appears advisable up to the maximum amount of \$ _____. Further, I hereby authorize HIHP and their agents to have this dog destroyed if the injury and/or illness is severe and/or if the destruction of the animal is deemed by HIHP or a veterinarian, the humane disposition treatment, and if the expense of the immediate and subsequent veterinarian fees will exceed the above amount within thirty (days). I understand, HIHP or their agents may be required to transport this dog off the premises for veterinary or other services and I authorize them to do so at the reimbursable fee of \$50.00 per hour and \$0.65 per mile. I agree to pay all expenses incurred by HIHP and their agents and to pay any and all the veterinary fees to HIHP, if HIHP have paid such expenses on my behalf, within three (3) days of notification. **Initial: _____**

LIABILITY

I hereby agree to be held responsible for any and all damage or injury to this dog or caused by this dog to other dogs, people or property while at Hastings Island Hunting Preserve ("HIHP") I acknowledge that the last scheduled walk-trough of the kennel is at approximately 4:00 PM daily and that, although one or more HIHP employees may live in proximity of the kennel, no nighttime or 24-hour per day inspections are scheduled. I agree to hold Knob Hill Mines, d.b.a Hastings Island Hunting Preserve, Hastings Island Land Company, Reclamation District No. 2060, owners, agents, employees and contract employees harmless from any and all claims or losses or injuries or sicknesses to this dog, or caused by the dog; or for any losses or injuries or sicknesses caused to any other dog or any other animal or any person which may be alleged to have been caused directly or indirectly by any act or failure to act, or any condition of said dog while at this facility, or while on HIHP property, or for any act or condition of said dog subsequent to completion of said boarding, or as a direct or indirect result of such boarding, whether caused by negligence of these persons or entities or not. I further agree to indemnify the persons and entities named herein from and against any and all costs, attorney fees, expenses, veterinary expenses and liabilities that they may incur as a result of any such claims or actions brought thereon.

DESTRUCTION OF ANIMALS

Notice is hereby given that any animals deposited at this kennel are subject to being destroyed in accordance with **Section 1834.5 of the California Civil Code**, which reads in pertinent part: *"Notwithstanding any other provisions of law, whenever any animal is delivered to any veterinarian, dog kennel, cat kennel, pet-grooming parlor, animal hospital, or any other animal care facility pursuant to any written or oral agreement entered into after the effective date of this section, and the owner of such animal does not pick up the animal within 14 calendar days after the day the animal was due to be picked up, the animal shall be deemed to be abandoned. The person into whose custody the animal was placed for care shall first try for a period of not less than 10 days to find a new owner for the animal, and, if unable to place the animal with a new owner, shall thereafter humanely destroy the animal so abandoned"*. If I should fail to pick up this dog or make other arrangements within fourteen (14) days after the pick-up date indicated, HIHP shall be authorized to transfer ownership of said animal to a person of their choice and sell this dog for the boarding and related fees and to keep and retain any funds in excess of the boarding and related fees.
